

## ServSafe Certification and Recertification Course Announcement

Indian Hills Community College is sponsoring a monthly ServSafe Course/Testing for foodservice owners, operators, managers, and supervisors. It is an excellent opportunity, offered locally, to become certified or to renew certification. (ServSafe Certificates expire 5 years from the date of issuance.) The program's focus is on food safety using materials developed by the National Restaurant Association's Educational Foundation.

The class and examination are on the same day. Participants will take the certification/recertification examination at the end of the session.

### Course Information

The classes will be the **first Friday** of each month, 8:00 to 5:00 p.m., in the Arts and Sciences Building on the Ottumwa Campus, Room 154-156 located at 525 Grandview Ave, Ottumwa, IA.

The course cost is \$125.00 per registrant. This fee includes the current edition of ServSafe Essentials, course materials and test.
